INFORM THAT

According to art. 13 UE regulation n. 679/2016 (defined as "GDPR") and Privacy Code D. Lgs. 101/2018, personal data will be treated as follows:

1. Purpose and Legal Basis of the Processing

The personal data, processed by the co-owners through the production and subsequent publication on the website www.udninternational.org of photographic surveys of the interested parties, are collected exclusively for purposes of study and scientific research as well as for the assistance of Rare Patients. the ISS and the Foundation intend, in fact, to disseminate the aforementioned photos among researchers around the world in order to help those suffering from a rare disease to find a diagnosis.

The co-owners process the data referred to in point n. 2 only insofar as they are indispensable for the achievement of the purposes of study and scientific research as well as treatment and diagnosis.

The **legal basis** for the processing of personal data referred to in point n. 2 of the following privacy information is found in art. 9, par. 2, lett. a) GDPR, as "the interested party has given his explicit consent to the processing of such personal data for one or more specific purposes (...)".

The interested party has the right to revoke his consent to participation, previously given, at any time and with the ease with which he has given it, pursuant to art. 17, paragraph 1, lett. b) GDPR.

However, this revocation does not affect the lawfulness of the processing carried out on the basis of the consent previously given and will have the sole effect of terminating the processing of the data subject's personal data for the future.

2. Categories of Personal Data

For the purposes referred to in point n. 1 and through the UDNI network website, the following categories of personal data may be collected and subsequently processed:

- Health and health data;
- Photographic surveys
- Genetic data

3. Processing methods

The processing of personal data is carried out by means of the operations indicated in art. 4, par. 1, no. 2 GDPR and more precisely: collection, registration, organization, storage, consultation, processing, modification, selection, extraction, comparison, use, interconnection, blocking, communication, cancellation and destruction of data.

4. Retention period

Personal data will be kept for a period congenial to the realization of the purposes of assistance to Rare Patients referred to in point n. 1 of this privacy information, as well as for scientific research purposes.

5. Access to personal data

Data will be accessible by scientist and researchers involved in UDNI activities

6. Rights of the interested party

The owner of the personal data, in his capacity as an interested party, has the rights referred to in art. 15 GDPR et seq., More precisely right of access, right of rectification, right of cancellation, right of limitation of treatment, right to data portability, right of opposition, as well as the right to lodge a complaint with the Guarantor Authority (art.77 GDPR and 141 of the Privacy Code, as amended by Legislative Decree 101/2018).

The interested party has the right to revoke his consent, previously given, at any time and with the ease with which he has given it, pursuant to art. 17, paragraph 1, lett. b) GDPR, without compromising future medical care.

However, this revocation does not affect the lawfulness of the processing carried out on the basis of the consent previously given and will have the sole effect of terminating the processing of the data subject's personal data for the future.
